The 111th China Food and Drinks Fair will be held at the Shenzhen World Exhibition & Convention Center from October 29th to 31st, 2024. In addition, special closed-door selection meetings will be held for Southeast Asian and Russian purchasers to further enhance the trade matchmaking ability of the CFDF and provide real global trade value for enterprises.

The 111th China Food and Drinks Fair will hold 20 professional forums and activities during the same period. Key forums and activities include CFDF Food and Beverage Industry Development Conference, CFDF Omni-Channel Purchasers Selection Meeting, the 111th CFDF Wine Brand Officer Forum, 2024 CFDF (Shenzhen) Jiang-aroma Baijiu Conference, the 20th Gold Product and New Channel Summit, etc. Combined with the characteristics and industrial advantages of Shenzhen, the food science and technology theme "One Exhibition, One Conference" is specially planned to promote the development of new quality productivity of the industry. 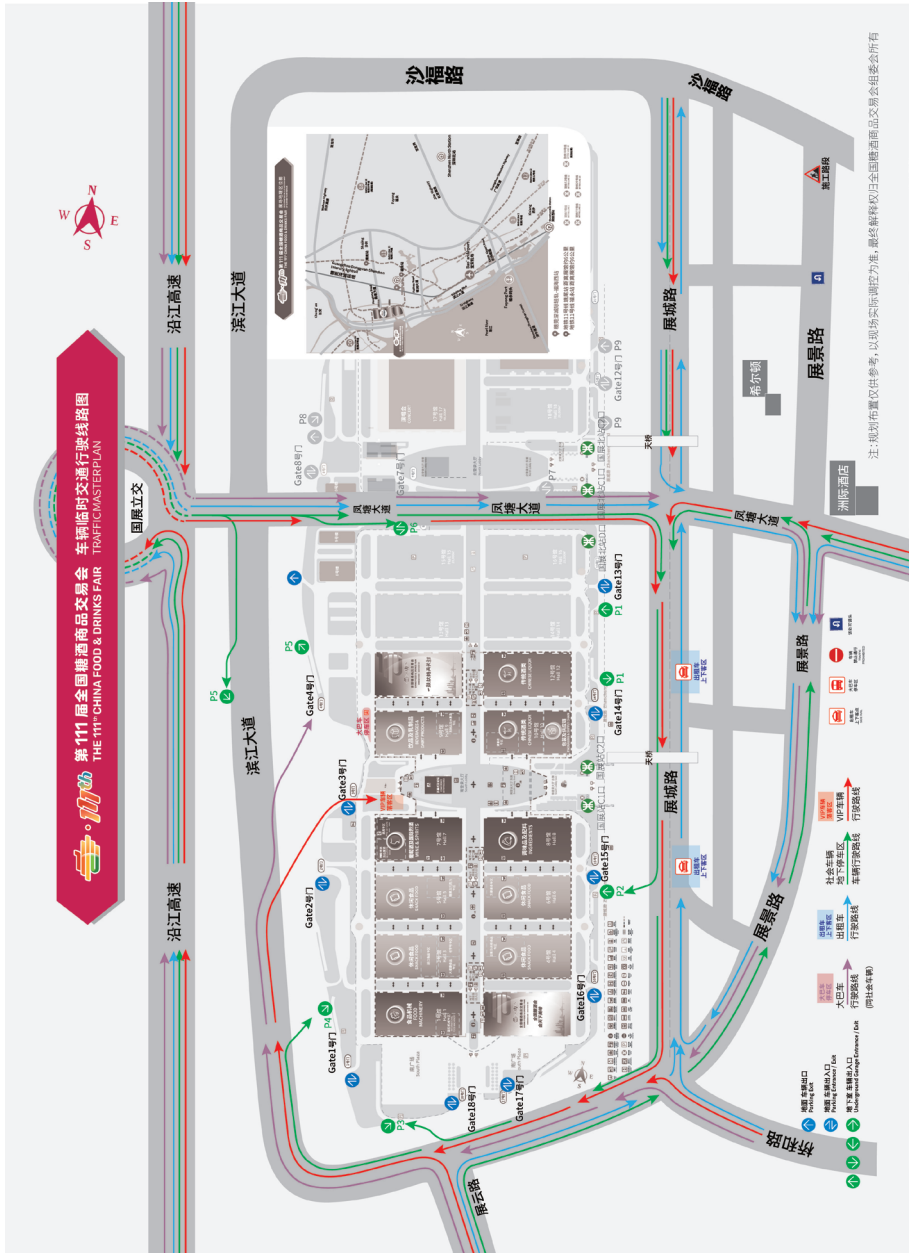

Regulations On Exhibition Management

02

2-1.General Provisions

- (01) In accordance with the relevant laws and regulations of the People's Republic of China and the directives of relevant government agencies, relevant government agencies, the general provisions have been revised for clauses and requirements including but not limited to safety production, fire safety, and document management. Exhibitors, booth builders, and service providers are required to strictly abide by them.
- (02) The overall layout of the booths is unified and planned by the organizer.
If the organizing unit deems that changes in the layout or location of the corresponding booth are advantageous to the exhibition, it has the right to make adjustments to their distribution.
- (03) Exhibitors are not allowed to transfer or sublet part or all of their booths. The actual user of the booth must be the exhibitor who has signed the "Exhibition Contract" with the organizing unit.
- (04) Before the end of the exhibition, all booths and exhibits must be in normal exhibition and operation status, and the exhibition cannot be ended prematurely for any reason.
- (05) All booths must be clearly marked with the corresponding exhibitor's company name and booth number. The content of the marking must not violate Chinese laws and regulations or relevant exhibition regulations.
- (06) Booths must be clearly divided according to the area specified in the contract, and the booth structure must not exceed the agreed boundaries; if there is any violation, the organizing unit has the right to ask exhibitors to rectify and bear the relevant costs.
- (07) Exhibitors are not allowed to display, hang, or distribute any items outside their booth boundaries.
- (08) To ensure the overall visual effect, the structure and layout of the booths should be considered to avoid obstructing the view of other booths. The principle of the main channel booth is to ensure that there are no obstructions on both sides, and it is not allowed to obstruct the view of adjacent booths on the same visual surface. The construction structure must not exceed half the depth of the booth.
- (09) All booths must ensure integrity and aesthetics, and at the same time comply with the quality standards and safety standards of the organizing unit and relevant government departments; if there is any violation, the organizing unit has the right to request rectification and bear the relevant penalty costs.

2-2. Basic Regulations of Exhibition Areas

To ensure the success of the 111th China Food and Drinks Fair (hereinafter referred to as the "CFDF"), protect the exhibitors and viewers property and ensure personal safety, prevent fire accidents and personal injury and mortality, we hereby release the exhibition area safety and fire control rules:

- (01) Exhibitors and booth construction companies shall strictly observe the Fire Safety Management Regulations of Organs, Groups, Enterprises, and Institutions, as well as the Safety and Fire Control Rules of the International Expo, shall designate officers in charge of fire control and safety, and enter into a related commitment with the CFDF organizing committee.
- (02) Decoration and construction of booths shall conform to the safety criteria. Before decoration, the booth decoration plans, drawings and materials shall be reported to the organizing committee for examination. After all the booth decoration and construction plans have passed the examination and been acknowledged to be up to standards, the decorating and booth construction companies shall sign the raw space booth construction safety and fire control safety commitment with the CFDF organizing committee before going through the formality of launching construction of the booth. Custom built stands shall have two or more outlets in addition to fire passages and the main passage. Booths located at emergency openings shall have an open design, and no wall or block shall be designed or located at the fire passages, freight doors or fire exits so as to keep these passages open. Exit instructions, warning signs and no-smoking signs shall be affixed at these places.
- (03) Smoking or the bringing into the exhibition area of any flammable, explosive items and pets is absolutely prohibited. The materials for booth decoration must be made with non-combustible or fireproof material. Any combustible, poisonous or harmful material used for decoration is absolutely prohibited. If it is really necessary to use any combustible material, it shall be processed to be fireproof as required.
- (04) The booth shall be equipped with a certain quantity of fire control appliances based on its size. Exhibitors may bring fire extinguishers themselves or rent them at the location designated by the CFDF organizing committee. Fire extinguishers brought by the exhibitors shall be examined and approved by the exhibition area's fire control team.
- (05) Any unauthorized circuit connection, installation of spotlights or sunlamps or the like, the use of canned liquefied petroleum gas, gas stoves, or electric heating appliances is strictly prohibited.
- (06) Any dangerous operation with open fire, cutting, polishing, gas welding, electric welding, spray painting, or benchtop electric saw operation are strictly prohibited.
- (07) Electrical workers declared in advance must match the actual operators on-site responsible for connecting all electrical appliances (including but not limited to distribution boxes, lamps, sockets), and their certifications must be checked. Lighting fixtures, neon lights, various electrical facilities, and materials must have national

professional safety certification. Ballasts must not be installed on combustible materials. Standard double-insulated flame-retardant cables must be used to connect electrical equipment, and other forms of cables are strictly prohibited. The electrical load of the booth must not exceed the total load of the connected electrical box.

- (08) All construction workers shall duly fasten his/her safety belt, wear a safety helmet, and use safe lifting tools and platforms for on-site operations or for work at height. The construction site shall have a safety supervisors responsible for the safety of the booth's construction. Any booth construction companies breaching any safety rules will be required to make rectification by the organizing committee in accordance with the applicable rules.
- (09) Hanging or hoisting any booth structure onto the net rack at the ceiling of the exhibition hall is strictly prohibited. Setting up a booth or piling up anything under the fire resistant rolling shutter door, in the public fire passage or within the area signed with yellow lines, or covering up, burying, occupying or blocking any fire control facility or equipment (fire extinguishers, fire hydrants, infrared sensor, automatic fire extinguishing system and its pipes, all sorts of shutter doors, emergency exits, detectors, fire exits, etc.) of the exhibition hall is strictly prohibited.
- (10) Dismantling, removing or damaging any facility or equipment of the exhibition hall is strictly prohibited. No booth construction company is allowed to use the power distribution box, water source or any other fixture of the exhibition hall without permission. Unauthorized opening of manhole covers inside the hall is prohibited. Hanging structural load-bearing objects on facilities without permission is prohibited.
- (11) It is prohibited to aim spotlights and other heating devices at or near fire sprinkler devices. Bringing balloons, drones, and other unapproved items into the hall is prohibited. Smoking is not allowed in non-designated areas. Stacking flammable materials such as empty cardboard boxes inside booth storerooms is prohibited.
- (12) Related CFDF management staff shall have the right to require any exhibitor or constructor breaching any of the above rules to stop operation, rectify their misdoings or errors immediately or within a time limit. Those who fail to abide by such managerial instruction will have their eligibility for CFDF and for booth construction canceled, and will be transferred to the police. Any safety-related accident, liability, or any economic loss resulting from said breach of this rule will be assumed by the concerned exhibitor and constructor in full.

Sanitation Rules

- (01) During the booth construction period, any packaging, waste, debris or the like shall not block the aisles in the exhibition hall. Every day upon finishing the day's work, the constructors must clear out their waste and rubbish.
- (02) During the CFDF session, the exhibitors shall perform cleaning of their booths by themselves, and the Fair will only provide cleaning for the public area; any rubbish other than that of the public area, and any exhibit or exhibition furniture in the booths shall be cleaned and maintained by the concerned exhibitors.
- (03) During the CFDF session, the exhibitors shall clear up and carry their own rubbish to the designated place by the close of the venue every day. Do not pile any rubbish in the aisles or in the public area.
- (04) During the dismantling period, the construction unit and the person in charge of the booth must withdraw the exhibits, booth decorations and available components within the time period specified in the "Exhibition Schedule". After the venue is cleared, all personnel are not allowed to enter the exhibition hall again.

Provisions on Intellectual Property Rights

- (01) All parties shall strictly comply with the provisions of the Food Safety Law of the People's Republic of China, the Advertising Law of the People's Republic of China, the Trademark Law of the People's Republic of China and other relevant laws and regulations. The exhibits shall conform to the requirements set forth in the relevant national and industry standards, no counterfeit, substandard or infringing exhibits shall be exhibited, and no articles involving dangerous factors or other illegal items shall be carried into the exhibition areas.
- (02) The Instructions for Participation in the 111th China Food and Drinks Fair, Letter of Undertakings of Exhibitors of the 111th China Food and Drinks Fair and other relevant management rules of the China Food and Drinks Fair shall be strictly complied with.
- (03) During the exhibition, exhibitors must carry relevant intellectual property documents. If complaints about relevant intellectual property rights documents carried into the exhibition areas during the exhibition and owned by exhibitors are received, the exhibitors shall take the initiative in cooperating with the organizer of CFDF and the competent IP rights administration to carry out the relevant activities. If IP rights issues are identified, reports may be made to the Administration Service Center or Complaint & Reporting Center set by the organizing committee. Any commercial promotion activities may only be conducted in the concerned exhibitor's own booth. Taking any photos or videos in any other exhibitor's booth without permission is strictly prohibited.

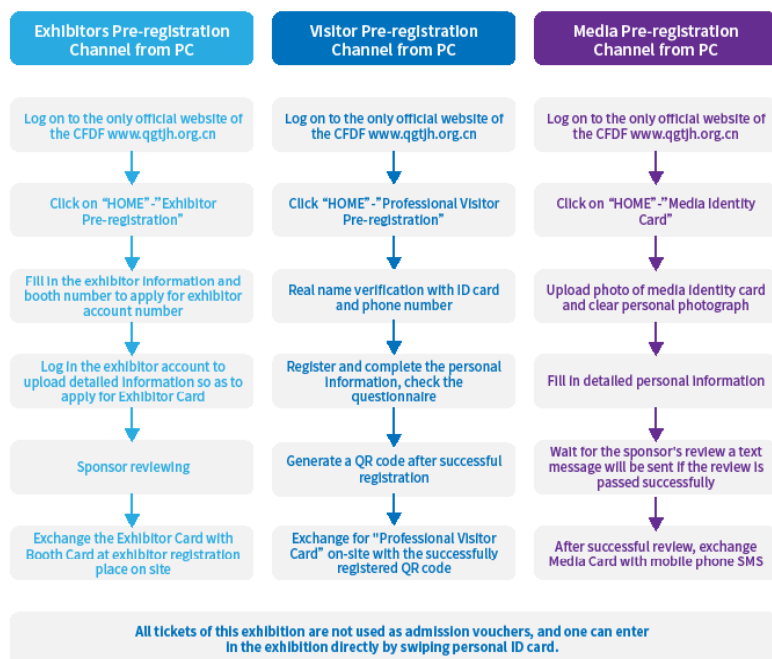

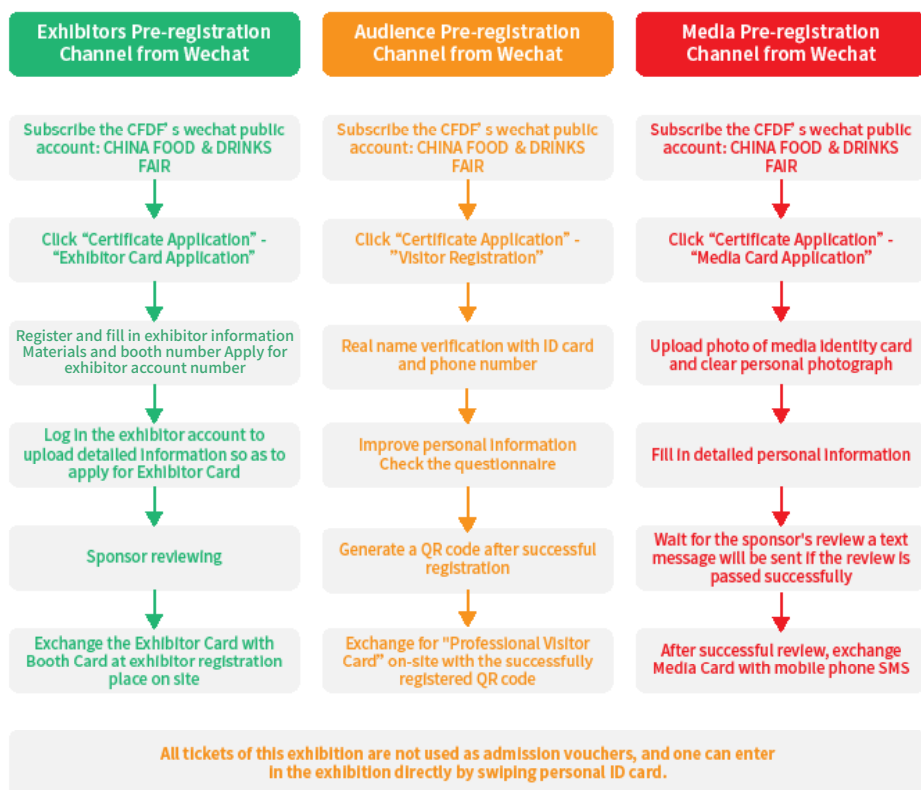

Overtime pay below 72m² is calculated according to 72m², above 72m² is calculated according to the actual area, overtime less than 1 hour is calculated according to 1 hour, and so on.
3. No early entry is allowed for special booths.

7. After the exhibition, if the fire extinguisher is not returned, the standard of 100.00 yuan/set will be deducted from the construction deposit.

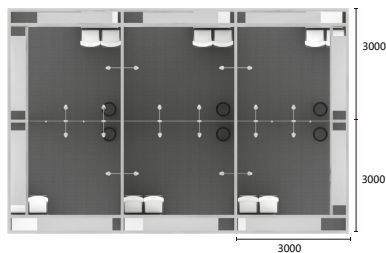

4-5. Special Booth Design and Construction

1. Instructions and Clarifications Pertaining to the Submission of Drawings

- (01) All drawings must be clear and complete, and the booth number should be clearly indicated in a prominent position on the drawings.
- (02) The circuit diagram must be clear and detailed. Specify the nature of electricity usage (mechanical equipment and lighting should have separate circuit switches and should not be mixed), total power, rated current and voltage of main switch and protection switches at each level (220V/380V), and specify the cable model and laying method used.
- (03) The circuit diagram indicates the location of the main distribution box for the booth. The circuit diagram also needs to indicate the type, power, and installation location of the lighting fixtures and other electrical appliances.
- (04) All the above-mentioned application materials must be filled out clearly and completely, and stamped with the official seal. Please submit the application through the "Home Service Channel" on the official website of the CFDF. After the application drawings are approved, please pay the relevant newspaper fees through the public bank account.

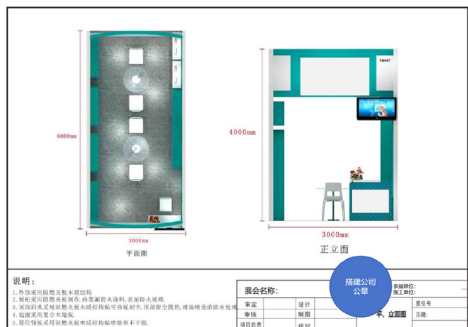

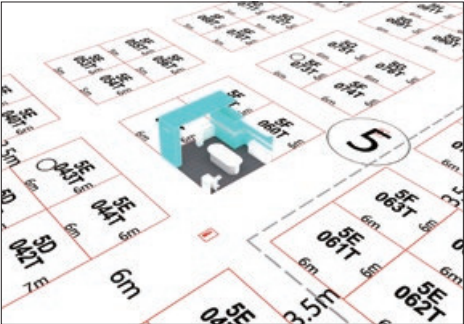

2. Requirements and regulations for construction management of raw space

Strictly abide by the Work Safety Law of the People's Republic of China issued by the relevant state administrative departments, "Regulations on the Safety Management of Large-scale Mass Activities" and other relevant government departments of the host country. Comply with the construction management regulations of the National Sugar and Wine Association Organizing committee and the home service providers, cooperate with supervision and inspection to ensure the safety of the booth structure and personal safety.

2.1 Structural Safety

- (01) **The booth construction shall not exceed the limited height**, and it is not allowed to build any form of two-story booth. Strictly abide by the site net floor height limit of 5m, B, C, D class standard booth to change the net floor height limit of 4m. Any form of alteration is not allowed for Class A standard exhibition booths. If Class B, C and D standard booths need to be modified or built by themselves, the exhibitors shall declare to the home service providers before 15 days before the exhibition starts. After the approval of the Organizing committee and payment of the fees, the home service providers shall arrange personnel to take charge of the implementation, and bring them into the scope of clean booth management. Without advance declaration, the Organizing committee has the right to refuse his entry.
- (02) It is forbidden to use wooden ladders, portable miter ladders shall not exceed 2 meters, single ladders shall not be used with a high pad, and steps shall not be missing. The spacing should be 300mm. When used, it should be at 75 degree Angle on the horizontal plane, and can not stand on the top of the miter ladder. Only one person is allowed to work on the ladder, and at least one person is arranged on the escalator, and No one is allowed to stand on the ladder while it is moving. No ladders shall be used on the scaffold operation level. When using ladders in the passageway, there should be special personnel to watch and help or set up fences. For more than 2 meters, mobile scaffolding with complete, effective and firmly connected accessories must be used. Mobile scaffolding must be accepted by the home court and the suspension acceptance certificate can be used. It is prohibited to use any damaged, bent, seriously rusted (affecting safety), altered or other structurally damaged accessories. The ratio of height to width should not be higher than 3:1, the construction load should not exceed 1.5kN/m², the protective railing should be set up not less than 1.2m, the mobile scaffolding wheel body should be firmly linked, the distance from the bottom of the column to the ground should not exceed 80mm, the walking wheel and the guide wheel should be equipped with a brake or brake and other fixed measures, the carrying capacity of the walking wheel should not be less than 5kN, The braking torque of the brake shall not be less than 2.5N·m, the operating platform shall be kept perpendicular to the frame, shall not be bent and deformed, and the walking wheel brake shall maintain the braking state except in the case of movement. The scaffold can support up to 2 people working at the same time, and arrange at least 1 person to support the scaffold; if there is a pulley at the bottom of the scaffold, the foot brake should be locked to prevent movement. Operators must properly wear safety protective equipment (safety belt, helmet, wear tool bag, etc.) that meets national safety requirements when operating mobile scaffolding. When the height exceeds 5m, personnel must use qualified lift trucks for operation. Construction personnel are not allowed to climb, stand on the exhibition frame of the booth, and are not allowed to transfer tools when working at height. Safety belts must be worn for high work, and the safety belts should be hung on strong components. At the same time, special personnel should be set up to monitor and prevent other personnel from entering the high working area.
- (03) The special booth shall post the booth number on the prominent position of the structure (limited size 350mmLx180mmH, screen template provided by the home service provider).
- (04) The construction unit shall design and construct according to the exhibition construction management regulations, provide construction drawings for review, and pay the net construction management fee and deposit. The orthographic projection of the booth built by the construction unit shall be within the line of the ground. If there is any deviation, the organizing committee and the home service provider have the right to order the construction unit to remove the excess line, and the costs and responsibilities incurred shall be borne by the construction unit.
- (05) The construction unit must have a site person in charge at the site to ensure that each booth is equipped with a person who can follow up the construction of the booth at any time and cooperate with the relevant work of the Organizing committee in a timely manner, and register and record when handling the construction procedures.
- (06) The design and construction strength of the booth structure should meet the strength requirements required to bear the load, and the design and construction should be strictly in accordance with the safety regulations of relevant state departments. The construction unit shall ensure that the overall structure of the booth has the strength and stability required to meet the load, the steel structure material meets the national standards, and the welding and connecting parts meet the safety requirements of the relevant national departments.
- (07) The floor thickness of the main wall of the booth structure shall not be less than 150mm, the floor thickness of the light steel keel as the main body shall not be less than 8cm, and the thickness of the special booth wooden wall without frame structure shall not be less than 35cm to ensure the contact area between the wall and the ground, and the height of the wooden wall over 3m must be supported by square steel or

seamless round pipes. The single span of wooden structure shall not exceed 6m, and the single span of steel structure and steel-wood mixed structure (including steel-lined square cylinder and iron frame) shall not exceed 8m. The back wall and the front display part should be connected with a steel structure, and the lower part should be supported by steel structure columns and a chassis, whose diameter is not less than 600mm. The supporting columns should not stand directly above the platform to ensure the overall strength and stability of the booth. Truss structure must use professional truss structure (need to provide the factory design manual or the design drawings provided by the qualified design unit for reference), it is prohibited to use the truss welded by itself; Metal fasteners must be used between the column and the beam of the truss, and the joint must be tight, without gaps and without shaking.

- (08) All the clean floor booths with beams attached to the top shall provide detailed structural drawings of the connection between the beams and the main body, and the structural strength shall meet the strength required by the load. The connection between the beam and the column must use bolts or other safety fixing materials. Simple connection methods such as lead wire, iron wire, and steel wire, such as lap bonding or binding, are prohibited. The connection mode of the main component shall not use gun-nails or wood grain screws, and must be fastened with bolts in full position. Lintel, ceiling beam and wall connection must use support structure or embedded in the wall, to avoid side connection structure.

2.2 Fire and electrical inspection safety

- (01) The selection of booth construction materials should meet the standards for the use of temporary construction materials by relevant state departments, and combine the characteristics of the exhibition with reasonable selection of materials, and the selection should meet the national environmental protection requirements. In addition to the exhibits, all items used in the booth or other buildings (such as walls, carpets, floors, ceiling, light boxes, wall painting and other construction, decoration, decoration materials) shall be used in line with the relevant state departments approved by the non-combustible or non-combustible materials, the combustion performance level shall not be lower than B1 (non-combustible level). The combustion performance level of the booth construction and laying carpet shall not be lower than B1 level (refractory level). For a small amount or local use of combustible materials such as wood structure, top mesh cloth, etc., flame retardant and fire treatment must be carried out (required to complete the treatment before entering the site), reaching B1 level (refractory level) can be used. It is prohibited to use polystyrene as decorative materials (including KT board, foam, etc.), stretch cloth, curtain cloth, yarn products, bamboo, straw, simulated green plants and other flammable materials to decorate the booth (after fire retardant treatment is also prohibited). The use of construction materials prohibited by the fire department is not allowed.
- (02) The use of glass materials to decorate the booth must use tempered glass, and provide tempered proof for on-site reference, and have the 3C mark of the national standard. It is necessary to ensure the strength and thickness of the glass (the thickness of the curtain wall glass is not less than 10mm), and it is necessary to gradually increase the thickness of the glass and the anti-fragmentation strength according to the area used. The installation of the glass must be reasonable and reliable, and the metal frame must be made or the glass must be installed with professional hardware. The cushion between the frame and the hardware and the glass material must be made of elastic materials to ensure the safety of the glass. Large-area glass materials should be labeled clearly to prevent breakage and injury. If a glass floor is used, the structural support columns and walls must be fixed under the floor. Do not build the booth structure directly above the smooth glass surface to ensure the stability of the structure.
- (03) The bottom of the main load-bearing steel structure column should be added to the chassis (not less than 600mm) to increase the force area of it and strengthen the rigidity of the booth. The steel pipe with a diameter of more than 100mm and the thickness of the wall more than 2mm should be used for the column. The size of the base of the metal structure column should be determined according to the overall load of the booth. The column must be welded in the center of the base. The bottom welding chassis and the upper welding flange must use a whole tube to increase the contact area at the connection points; splicing is not allowed. The column cannot be placed directly on the platform; it must touch the ground directly to increase the stability of the main body. Wooden bearing columns should be made of unbroken solid materials to ensure the integrity of the structure, and the joint parts should be firmly connected. The diameter of the metal structure lamp post shall be more than 10cm, and the bottom shall have a square plate with an area of not less than 100cm×100cm and a thickness of not less than 6mm, and shall be reinforced to ensure stability; Wooden bearing columns should be made of continuous solid materials to ensure the integrity of the structure, and the joint parts should be firmly connected.
- (04) It is strictly prohibited to hang or bind the booth structure and decorations on the top of the exhibition hall, columns, fences and various special pipelines without authorization. It is not allowed to paste tile (sheet), glass and other hard finishing materials on the main structure of the booth. The area of a single tile (piece) is limited to 122cm×244cm, beyond the scope to apply; Measures should be taken to prevent falling off, and must be pressed, slotted and pasted from the base of the bottom.
- (05) The angle steel, channel steel, square steel (pipe) and other materials used in the load-bearing components must meet the Chinese standard, and must not be used for decoration Flexible metal materials or brittle materials. If the profile uses corner codes, the width of the corner codes must be greater than 50mm, the thickness must be greater than 5mm, and the connection is made of steel bolts. Thin wall bearing

members with pipe walls less than 0.8mm shall not be used, nor shall seriously corroded bearing members be used. External (hoisting) components must be metal frames and connected to the metal main structure, bolted.

- (06) During the construction period, all personnel entering the museum must wear a hard hat (the builder must prepare a hard hat for exhibitors who have the need to enter the museum during the non-development period, and the hard hat must have the LA logo and quality and safety certification mark) and construction documents. The construction personnel must wear the required tooling, and other clothing is strictly prohibited. Each booth should be equipped with a full-time safety person in charge of supervision and management of site safety construction.
- (07) The electricians declared in the early stage shall be consistent with the actual operators of the site who connect all electrical appliances (including but not limited to electric boxes, lamps and sockets) (and check whether they are licensed to work), and the construction personnel must carry professional protective equipment (such as insulating gloves, insulating shoes, safety hats, etc.) to work. When using ladders or scaffolds for electrical work or working near electrical lines, insulation protection measures should be taken on metal ladders or scaffolds. It must be ensured that the construction personnel of each profession only engage in their own professional construction, and cross-professional construction and operation are strictly prohibited.
- (08) It is strictly prohibited to carry out the initial processing of wood structure in the exhibition hall, and it is strictly prohibited to spray paint, scrape putty, and brush latex paint on a large area.
- (09) It is strictly prohibited to withdraw the exhibition in advance. Brutal construction is strictly prohibited. It is strictly prohibited to outsource non-construction and construction professional companies to carry out construction, construction and withdrawal. Adhere to the principle of "whoever constructs the newspaper" and prohibit subcontracting.
- (10) It is strictly prohibited to build a booth (exhibition frame) under the fire door of the exhibition hall, pile up various sundries and advertising materials, and the position of the fire door switch must be ensured.
- (11) The construction of the booth shall not block the fire fighting facilities, electrical equipment, emergency exits and audience evacuation channels in the exhibition hall, and the design and construction of the clean booth must leave two or more entrances and exits.
- (12) It is strictly forbidden to carry or use flammable and explosive and prohibited chemicals (such as alcohol, thinner, gasoline, etc.) in the construction of the booth; Hydrogen cylinders, oxygen cylinders, acetylene cylinders and other explosive products are prohibited. It is strictly forbidden to use electric saws, planers, gas cutting, welding, electric welding, electric drill and other special construction operations in the exhibition hall; The use of open flame in the exhibition area is strictly prohibited.
- (13) After the construction area and booth are completed, fire safety warning signs (200mm*300mm) such as non-smoking signs and safety evacuation passage signs must be posted according to regulations.
- (14) In addition to the temporary smoking area, smoking, drinking and other fire ceremonies are strictly prohibited in the whole exhibition area, and the use of electronic sparks and other props is strictly prohibited.
- (15) Every day after the exhibition, be sure to turn off the power supply of the booth except for 24 hours of electricity. The power supply and the lighting power supply must be connected separately with different electrical boxes, and a secondary electrical box must be connected at the lower end of the electric box in the venue, and the leakage protection device of the corresponding specifications must be equipped. The electric box should be fixed in a position where the flow of people is small and easy to operate by staff. It is prohibited to place the electric box in a closed area.
- (16) It is strictly prohibited to pull the power supply and water source privately, and it is not allowed to overload the power supply.
- (17) It is strictly prohibited to stack items near electrical boxes, switches and other equipment, and electrical boxes and switches installed on the booth structure must be isolated by adding insulation fire MATS.
- (18) Each special installation booth wire routing must be covered with insulated pipes (through PVC pipes or metal hoses) to ensure strict compliance with specifications to eliminate safety hazards. Be sure to use regular wires in line with national standards, it is strictly prohibited to use non-standard materials such as twist wires, and the connection of temporary electricity must use plugs. During the construction of branch connections at each booth, it is strictly forbidden to bandage with insulating tape directly. Plastic connectors, male and female terminal connectors must be connected, and insulation protection measures must be taken. The cable routing in the booth must be standardized.
- (19) The ceiling area of the booth is strictly prohibited to exceed 50% of the leased booth area, and the ceiling material must be kept at least 15 cm away from the lamp. And the selection of materials for fire retardant treatment.
- (20) The light box should be made of flame retardant grade or flame retardant material. The installed lamps and their heating components, such as ballasts, low-voltage transformers and other heating components should be kept at a safe distance from the wooden structure or a non-combustible isolation layer, and away from combustible materials, and the cable should be separated through the insulation tube. Light boxes shall be

provided with heat dissipation holes and painted with fireproof paint. Prohibit the use of plastic shell ballasts, high temperature heating lamps (such as tungsten iodide lamp, solar advertising lamp, etc.). It is prohibited to illegally install lamps and use high-power electrical equipment in the standard booth.

- (21) If the booth needs to be built with a platform and the height of the floor is more than 10cm, the transition to the ground needs to use a ramp. If the height of the platform is less than 10cm, it must be equipped with relevant step safety signs. When building the platform, barrier-free access must be set up at the edge of the platform within the booth area to access the public access, so as to prevent the difference between the platform and the ground from causing personal injury to the public. An anti-collision object or a safety Angle should be set up at the corner of the platform.
- (22) The booth shall be equipped with more than 5kg qualified and effective ABC fire extinguishers according to the requirements of 1 group (two) per 50 square meters, and placed in an obvious position.
- (23) Working with naked fire is strictly prohibited.
- (24) Unauthorized construction and construction is strictly prohibited without entering the site; Those who have not gone through overtime procedures are strictly forbidden to work overtime without permission or delay overtime work in violation of regulations.
- (25) Without the permission of the Organizing Committee, it is strictly prohibited to bring high-power electric saws, planers, cutting machines, air compressors and welders into the exhibition hall and the construction site.
- (26) During the exhibition period, the use of electricity without declaration is strictly prohibited; If exhibitors apply for 24-hour power supply for electrical equipment, they must post clear signs to ensure that there is no hidden trouble in the booth, and set up appropriate and reliable maintenance switches.
- (27) The construction unit shall construct within the specified time and area, and be responsible for fire prevention, anti-theft and other safety work.
- (28) It is strictly prohibited to damage the facilities and equipment of the exhibition hall; It is strictly forbidden to punch holes, nail nails, paint or paint on the floor and wall of the exhibition hall; Misappropriation of display equipment is strictly prohibited.
- (29) When the booth is higher than the adjacent booth, the exceeding party shall carry out white smoothing and beautifying treatment on the back of the booth; It is strictly prohibited to arrange propaganda text or enterprise logo on the back; It is strictly prohibited to use the structure of the adjacent booth as its own booth construction structure or support structure.
- (30) If there is a safety hazard in the booth construction, the construction unit must rectify on time after receiving the rectification notice issued by the home service provider; After the completion of the rectification, timely notify the home service provider to check the rectification results and do the cancellation process.
- (31) During construction, the construction unit should clean up the waste at any time, and the materials for building the booth should be neatly placed. It is strictly prohibited to occupy the fire escape and keep the passage in the exhibition hall unimpeded. It is strictly prohibited to set up a warehouse for storing goods in the exhibition hall. To remove the booth within the specified time, complete the construction of garbage removal, and prohibit stacking and discarding the construction of garbage in any public area.
- (32) confrontation are strictly prohibited at the exhibition site, and personal rights protection and other behaviors that are not reported to the relevant management departments in advance are strictly prohibited.
- (33) During the exhibition period, the construction unit shall keep electricians, carpenters and other personnel on duty, and solve problems in time. In addition, if the booth is held down by the electric box, the builder shall inform the exhibitor of the obligation, and communicate with the exhibitor in time in case of power failure.
- (34) It is prohibited to discharge the exhibition hall any hazardous waste substances that can congeals into clot, such as animal and plant oils, flour and cream, and contain any toxic and harmful waste substances such as emulsion, cyanide, acid and alkali, industrial oil and heavy metal ions. Such goods should be packaged by the builder to assist the exhibitors to take them away from the red line of the exhibition hall and dispose of them by themselves.

3. Management requirements and rules for the use of lifting points

- (01) The standard exhibition halls of Hall 1, Hall 3-10 and Hall 12 cover the whole hall with a single point bearing capacity of 1t/ per point. And the bearing capacity of each main truss is within 18T; The height of the upper edge of the booth hanging structure should be smaller than 9.0m, the height of the hanging flag should be greater than 9.5m, and the hanging flag itself should be within 9.5-16.0m.
- (02) The lifting point cannot be used for other non-hanging objects and equipment; Can not be used for the suspension of any moving object; Pure wood structure shall not be suspended; Do not connect to the ground for any structural reinforcement; Shenzhen International Convention and Exhibition Center facilities and equipment safety shall not be suspended.
- (03) No part of the hanging structure shall be connected with the ground structure, except in special circumstances with the consent of the exhibition hall.
- (04) Do not lift or hang pure wood structure.
- (05) The hanging structure adopts the principle of a lifting point and a hoist vertical hanging, which does not allow crooked pulling. When the plane radius of a single hanging structure is less than 1.5m and the weight is less than 100kg, the configuration depends on the actual situation.
- (06) Do not hang subwoofer, line array speaker.
- (07) The structure size of the hanging shall not exceed the size of the booth itself.
- (08) The load bearing of the hanging structure should be evenly distributed, and it is not allowed to cause structural instability or other safety hazards.
- (09) The hanging objects use electricity, and the lines should be arranged neatly. The high-voltage wires should be laid with bushing, and the low-voltage signal cables should be arranged neatly without bushing. The wires should not be wrapped with tape, and the insulated terminals should be connected.
- (10) The connection between the hanging structure and the truss is firm and reliable.
- (11) The connection of the hanging structure and the hoist hook shall be connected with a special shackle for lifting, and detailed drawings shall be provided.
- (12) Each device installed in the hanging structure must be equipped with a separate wire safety device (drawings and drawings).
- (13) The fire retardant grade of hanging materials must reach B1 level or higher.
- (14) The complex special booth needs to provide the specific construction plan and construction technology, and provide the structural force calculation book (including the seal of a registered structural engineer).
- (15) Suspension structures are not allowed to have overhanging components.
- (16) The lifting point system of the venue is not allowed to directly bear dynamic loads.
- (17) The main load-bearing truss structure must use special trusses and meet the requirements of national norms, the connection is solid and reliable, and the material specifications and models of the load-bearing trusses need to be provided, and the detailed connection method is strictly prohibited.
- (18) The load-bearing limit of the hanging point needs to consider the influence of the dynamic load amplification factor of 1.3 during the use process.
- (19) Within the load-bearing range of the point position, the lifting point span of the 300*300 aluminum alloy truss (space frame) should be within 4.5m, the lifting point span of the 400*400mm aluminum alloy truss (space frame) should be within 6.0m, and the lifting point spacing of the 400*600mm and above aluminum alloy truss should not exceed 9.0m, which is determined according to the actual hanging scheme.

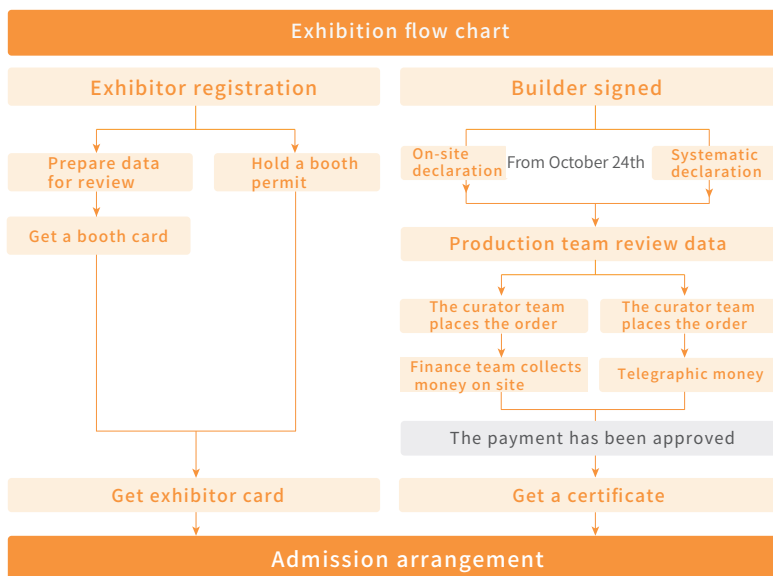

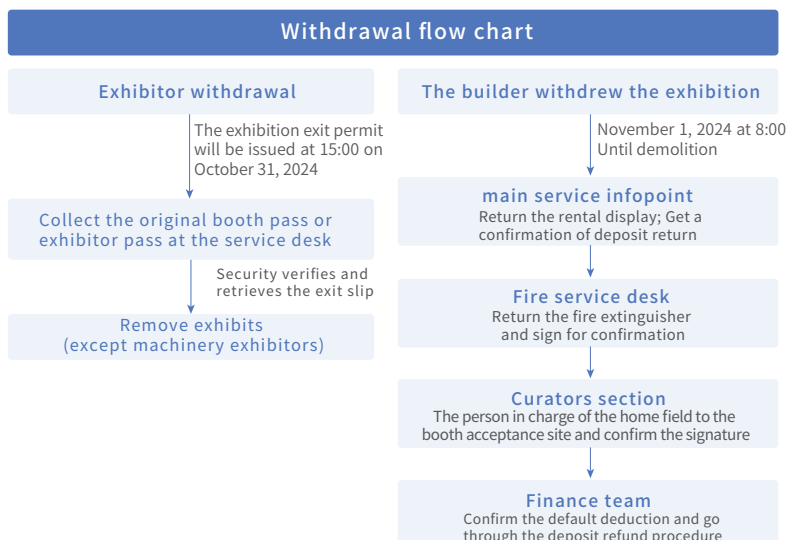

- I. This company has been confirmed as the only filling construction company for this exhibition booth after passing the inspection and review, and it has the qualification for construction and erection in the exhibition industry;
- II. Our company has signed a relevant construction contract with the contractor, and urged them to purchase relevant insurance to ensure the safe and normal construction of the exhibition booth.
- III. Our company has a thorough understanding of the relevant construction management rules for the the China Food and Drinks Fair Area, and has instructed the contracted construction company to strictly adhere to the management regulations and comply with the management arrangements.
- IV. Our company will cooperate with the organizing committee, safety supervisors, and main venue service provider in overseeing the safety of the exhibition stands. If the contracted construction company violates the relevant construction safety regulations of the exhibition hall, the organizing committee has the right to deduct the security deposit paid by them according to the regulations.

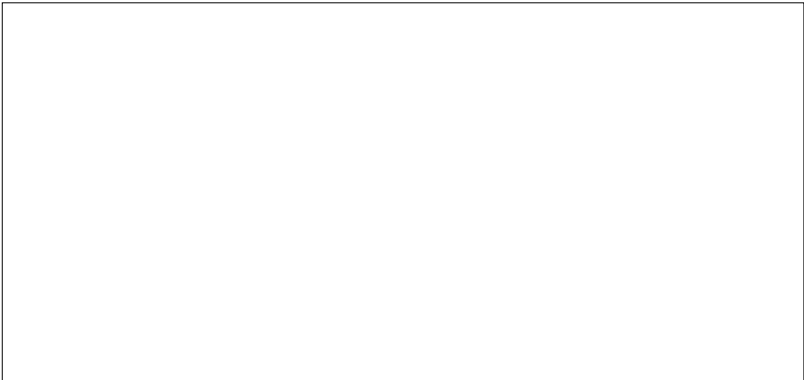
